# (Extension) Regarding Application to the job Position of Researcher

Transportation Institute Chulalongkorn University wishes to hire a university employee for the position of Researcher in the field of Urban logistics and supply chain management, National and regional logistics and supply chain management, International logistics and supply chain management, Rail, sea and air transport, Air transport, Aviation management, Aviation industry, Public transport system design, planning, and management, Regional transport network design and planning, Highway engineering, Traffic engineering (1 position) with a salary of 41,000 - 56,400 (The initial salary for each qualified applicant is considered based on several factors as per the University's regulations.) to perform the task of Transportation Institute with the following qualifications:

#### 1. General qualifications

Applicants shall hold required general qualifications as per Chulalongkorn University's Human Resources Management Regulation B.E. 2557 regarding general qualifications for university employees as stipulated below.

- 1.1 Being of age not less than eighteen years old;
- 1.2 Not being a person of unsound or frantic mind, an incompetent person, or a quasiincompetent person, or suffering a disease specified in the University notification;
- 1.3 Not undergoing suspension from work, suspension from public service, or an order of temporary dismissal from public service office;
- 1.4 Not holding a political office, directorship in a political party, or an officer position in a political party;
- 1.5 Having never been sentenced by a final judgment to imprisonment, except where the sentence is for an offence committed under negligence or a petty offence;
- 1.6 Having never been punished by way of proposed resignation or dismissal hereunder, or punished by way of proposed resignation, dismissal, or termination of the employment contract as a result of a serious disciplinary breach under any other regulation, rule, or notification effective prior to the date of this Regulation coming into force;
- 1.7 Having never been forced to resign, be removed, or dismissed from public service, a state enterprise, or another government agency, a private company, or an international organization;
- 1.8 Having never committed a dishonest act in an entrance examination for recruitment into public service or into employment in a state university or agency;

- 1.9 Not being a person who lacks good morals.
- 1.10 Not being adjudged bankrupt by the court or being in a state of bankruptcy;
- 1.11 The employment contract not having been revoked or terminated for not being awarded a Faculty Promotion within the determined period as per Chulalongkorn University regulation regarding human resources management B.E. 2557 or the University Council not approving the appointment of a Faculty Promotion.

## 2. Specific qualifications

- 2.1 Graduated with a Doctor's Degree in the field of Urban logistics and supply chain management, National and regional logistics and supply chain management, International logistics and supply chain management, Rail, sea and air transport, Air transport, Aviation management, Aviation industry, Public transport system design, planning, and management, Regional transport network design and planning, Highway engineering, Traffic engineering.
- 2.2 Having at least a required minimum score of English proficiency test
- 2.3 Male applicants shall be free, waived, or exempted from military service
- 2.4 Having research experiences in the fields of Urban logistics and supply chain management, National and regional logistics and supply chain management, International logistics and supply chain management, Rail, sea and air transport, Air transport, Aviation management, Aviation industry, Public transport system design, planning, and management, Regional transport network design and planning, Highway engineering, Traffic engineering.

- 3.2 Evaluation of specific knowledge for the position
- 3.3 Evaluation demonstrate an ability to teach effectively or presentation abilities
- 3.4 Evaluation of qualifications and suitability for the position
- 3.5 Interview

#### 4. Application documents

- 4.1 A 1x1 inch full-faced photograph (taken not longer than 6 months prior to the application)
- 4.2 Academic certificate(s) specifying the graduation date
- 4.3 English proficiency test results, either CU-TEP, IELTS or TOEFL, which shall be taken not longer than 2 years prior to the last application date

4.3.2	IELTS	at least 6.5 score	(Total Score 9.0)
4.3.3	TOEFL (PBT)	at least 550 score	(Total Score 677)
4.3.4	TOEFL (ITP)	at least 550 score	(Total Score 677)
4.3.5	TOEFL (iBT)	at least 79 score	(Total Score 120)

or graduated from the English programs in the United Kingdom, the United States, Canada, Australia, New Zealand, Ireland, Singapore, the Philippines, India, South Africa, and Hong Kong SAR.

- 4.4 Work certificates (Reference letter(s) in organizational management or other certificates)
- 4.5 A copy of the change of name certificate (if any)
- 4.6 A copy of the military service or military exemption certificate
- 4.7 A copy of the house registration and identification card

The documents in items 4.2 – 4.7 must be certified as true copies with an original signature before attaching the files to the website, along with the completed application form.
